

TERMS AND CONDITIONS

CRYSTAL BOWL CAMP September 17-22, 2017

IMPORTANT: Each participant must fill out a separate Agreement and submit it separately prior to September 1, 2017.

DEPOSITS: A non-refundable deposit of 1/2 Full Camp Fee will hold your spot through September 1, 2017. **Final payment is due: September 1, 2017 (July 31 for early bird discount).**

REFUNDS: Any cancellation made in writing between **July 1st and September 1st**, will result in a cancellation fee of 50% of the full camp pricing less the non-refundable deposit. No refunds will be given for cancellation made after **September 1st, 2017**. Please note that there will be no refunds or discounts for arriving late, leaving early, flight cancellations, travel delays or illness. We wish we could compensate people for unforeseen circumstances (injury, family emergency, etc.), but we have costs already incurred when arranging the camp.

ORGANIZER CANCELLATIONS: Crystal Bowl Camp Organizers reserve the right to cancel the camp if it is not meeting the camp minimum. (If we do so your deposit and camp fees will be is refunded in full). We strongly recommend participants obtain travel insurance at the time of booking as we do not cover cost of airfare, travel etc. cancellations.

INSURANCE: All participants in Crystal Bowl Camp are strongly advised to get travel, medical, accident, cancellation, and baggage insurance independently. The Retreat Organizers carry no insurance whatsoever for the Retreat Participants.

WHAT TO BRING: Crystal Bowl Camp is primarily an outdoor event subject to weather and the elements. Prepare for sunny days, rain and cool nights. Temperatures range from the 60s to the high 90s Fahrenheit. It is recommended to bring a flashlight, hat, tee shirts, shorts, pants, sweater, swimsuit, light jacket or coat, and slippers. If you plan on doing any hiking in the area we suggest socks, sturdy, comfortable hiking shoes.

CAMPING ACTIVITY: Crystal Bowl Camp is inherently an outdoor activity. As such, Participants acknowledge that there may be occasional discomfort. The accommodations are rustic. There will be bugs. There will be rain and wind at inconvenient times. The accommodations, services, showers and toileting facilities are safe, sanitary but are necessarily different than that of a hotel experience.

ROOMMATES: Crystal Bowl Camp Participants opting for the shared accommodation fee acknowledge that they will be sharing a sleeping space with up to four other persons. Camp Organizers will attempt to match Camp Participant with suitable roommates. If the Camp Organizers match the participant with roommates whom the Camp Participant deems unsuitable, Camp Organizers will endeavor to find an equitable solution. Should the Camp Organizers incur costs (Additional Tent Rentals, etc.) in satisfying the Camp Participant, then the Camp Participant must pay for the additional costs. There will be no refunds for complaints about roommates, and if any Camp Participant cancels the Camp because of a roommate, there will be no refund.

PUBLICATION RELEASE: Representatives of the Camp Organizers may be photographing, audio-recording and/ or video-recording the Retreat. The Camp Organizers reserve the right to publish any such photographs, audio recordings, and video recordings without obtaining further consent from any participant. Each participant releases The Camp Organizers and its representatives from any liability in connection with any such use of such photographs, audio recordings, and video recordings.

INHERENTLY DANGEROUS ACTIVITIES. Crystal Bowl Camp Participant acknowledges that he or she is willfully and with full knowledge participating in certain activities, including but not limited to a program outdoor activity that is inherently dangerous. The Crystal Bowl Camp Participant agrees to the following:

"I am entirely responsible for my own personal safety, health, and mental, physical, emotional, and general well-being during and after Crystal Bowl Camp. I release the Camp Organizers and their representatives, and any of their employees, assistants, and affiliates, of any liability for any injuries or damages mentally or physically I or any of my family members might incur during or after the Camp. I understand that the Camp is in no way psychotherapeutic or medical in nature. The Camp is not involved with the treatment of disease of any kind and does in no way substitute for medical diagnosis or treatment. Crystal Lober and other Camp leaders and teachers do not treat, prescribe, or diagnose any illness, disease, or any other physical or mental disorder. I am entirely responsible for my personal safety, health, and well-being during the Camp. I hold the Camp Organizers harmless for anything that might happen to me or to my possessions on this Camp. I understand that no health insurance or travel insurance is provided by the Camp organizers, and, if I wish to be insured, I have to do this myself.
